CHAIRMAN'S MESSAGE

As we begin the next decade of AIWF's work with renewed confidence following on from the memorable Special 2011 Programme in London to commemorate the founding of AIWF and to recognise the outstanding achievements of its first decade, we are constantly reminded that major changes are taking place in the Arab region as a result of the events leading up to the Arab Spring; in particular, democratic elections have now been held in Morocco, Tunisia and Egypt and will ultimately bring about a great transformation in the region.

AIWF has been at the forefront of international empowerment discourse for ten years, advocating sustainable, responsible reform and is now pressing for renewed efforts to ensure that the hard-won rights and achievements of women are not eradicated in an uncertain global economic and political climate. The Arab Spring has provided a significant opportunity for the contribution made by women to the stability and prosperity of their communities throughout the Middle East and North Africa to be enlarged and enhanced. In particular, it is imperative that the achievements and gains made by women in all sectors prior to the Arab Spring are not diminished or invalidated. Faced with the renaissance that is taking place in the region and international recognition of the need for employment, the Arab world needs to count women and youth among its vital resources if it is to achieve sustainable growth and more stable and prosperous communities.

As the subject of job creation and the empowerment of women and youth are central tenets of AIWF's mission and vision, the AIWF 2012 Conference entitled *Emerging Economies, Emerging Leaderships: Arab Women & Youth as Drivers of Change* to be held in May at the American University of Sharjah, United Arab Emirates, under the esteemed Patronage of His Highness Sheikh Dr Sultan Bin Mohammad Al Qassimi, Supreme Council Member, United Arab Emirates, Ruler of Sharjah and Founder and President of the American University of Sharjah, is aimed at bringing together Arab and global women and men leaders to address this timely theme.

We will be pressing for women and youth to reach out for the opportunities to contribute to shaping future Arab economic and social policy, to be involved in entrepreneurial excellence and take forward the message that the empowerment of women, poverty eradication, the enjoyment of human rights and economic equality are essential for sustainable development in the Arab world and developing economies. December 2011 involved a full schedule during which I chaired a meeting of the AIWF Board of Trustees which was kindly hosted by PricewaterhouseCoopers at their offices in Beirut, Lebanon.

As a key part of her visit to the United Arab Emirates, Founder Chairman AIWF, Mrs Al Kaylani, travelled to the American University of Sharjah (AUS) to meet with Chancellor, Dr Peter Heath, and Vice Chancellor for Development and Alumni Affairs, Dr Nada Mourtada-Sabbah, to finalise preparations and subsequently to launch the AIWF 2012 Conference.

Dr Peter Heath, Chancellor, the American University of Sharjah hosted a Special Reception and Luncheon in Mrs Al Kaylani's honour which brought together a distinguished guest list from Sharjah, the rest of the United Arab Emirates and the GCC.

In welcoming Founder Chairman of AIWF, Mrs Haifa Al Kaylani, to the luncheon held in her honour at the American University of Sharjah (AUS), Chancellor, Dr Peter Heath, paid tribute to her work in founding the Arab International Women's Forum in London to provide an organisation for Arab women to network and assist one another in their respective journeys in business, the professions and in many other dimensions of public life. He described AIWF as a community where its members make things happen.

Dr Heath went on to say that globalisation and education have greatly expanded traditional expectations and gender roles in the Gulf for women to ascend the ladders of success in business, industry and the professions. A recent study of the aspirations of university educated women at the American University of Sharjah and at three neighbouring institutions of higher education recorded that university educated young women hope for successful careers in the private sector as their primary goal, and even ahead of marriage and family.

Looking forward to hosting the AIWF Conference in Sharjah, he said, "This will be a fortuitous partnering of AIWF and the American University of Sharjah for our many overlapping goals."

Dr Heath concluded his remarks by saying, "The American University of Sharjah could not be more pleased to co-host the AIWF conference in May. With women comprising slightly more than half of our graduates, and women holding key positions in the Alumni Association, AUS welcomes Arab International Women's Forum with its path-finding efforts in advocacy, networking and mentoring."

• Muna AbuSulayman on being named Top Women Arab Influencer in Social Media, according to Klout and on being listed also as one of CEO Middle East's The World's 100 Most Powerful Arab Women. Ms AbuSulayman is an influential Arab and Muslim Media personality. She is also the former founding Secretary General of the Alwaleed Bin Talal Foundation, the philanthropic arm of HRH Prince Alwaleed Bin Talal's Kingdom Holding Company, and co-host of one of MBC TV's most popular social programmes, Kalam Nawaem.

As a public and media personality, she has spoken and written about issues related to society, women's rights, community development, media and building bridges of understanding between the East and West. In 2004, Ms. AbuSulayman was named a Young Leader by the World Economic Forum. In this capacity, she is often called upon to speak on issues related to challenges facing youth around the world. In 2007, she became the first woman from Saudi Arabia to be appointed by the United Nations Development Program as a Goodwill Ambassador. Ms Abu Sulayman will also be participating in the AIWF forthcoming Sharjah Conference as a distinguished Guest Speaker.

• Shahinaz Ahmed, CEO of EFE-Egypt, and an honoured Guest Speaker at AIWF's 10th Anniversary Conference in London last year, who was featured among eight female leaders making significant changes for the status of women in the Arab world and described by CNN on 3 February 2012 as "agents of change to follow". Shahinaz Ahmed who, in her role as CEO of EFE-Egypt, works with disadvantaged youth via market-based education, states that "One of the greatest challenges facing women in the region is freedom of choice. In order to have such freedom, economic independence is critical."

AIWF FOUNDER CHAIRMAN CELEBRATES INTERNATIONAL WOMEN'S DAY WITH THE ARABIAN SOCIETY AT UNIVERSITY COLLEGE, LONDON

AIWF marked **International Women's Day** this year, with **AIWF Founder Chairman, Mrs Haifa Al Kaylani** addressing members of The Arabian Society at University College London, the official society of University College London devoted to education, appreciation and discourse relating to the Arab world on the theme, *After The Arab Spring: The Role of Arab Women In A New Arab World*.

In her opening remarks, Mrs Al Kaylani said, "This International Women's Day, on behalf of the Board, Members and Global Partners of the Arab International Women's Forum, I would like to take the opportunity to honour and congratulate women all over the world for their remarkable achievements in advancing the issue of women's empowerment at all levels of economic, social and political debate.....International Women's Day affords us with the opportunity to recognise and celebrate those women on the ground who are shaping the future of the Arab world, making unprecedented contributions to national and regional economic, political and social decisions in pursuit of better opportunities for all Arab citizens."

Mrs Al Kaylani concluded her address by saying, "Every country in the [Arab] region faces a long and uncertain

few years ahead, but there are unprecedented opportunities for women and youth to claim a critical role in shaping the frameworks that will set legal, political and social precedents for the decades to come. AIWF is, as ever, proud and honoured to be a part of this process."

The United Nations began celebrating 8 March as International Women's Day in 1975 during International Women's Year.

Subsequently, the General Assembly adopted a resolution proclaiming a United Nations Day for Women's Rights and International Peace to be observed on any day of the year by Member States, in accordance with their historical and national traditions. For the United Nations, International Women's Day has been observed on 8 March since 1975. The day is traditionally marked with a message from the Secretary-General and it celebrates women's achievements throughout history and across nations.

Each year we are reminded of how much or how little progress has been made by women in view of the degree of struggle for economic and political empowerment above all else.

In terms of the progress of women towards economic and political empowerment and a little ahead of International Women's Day this year, on 2 February, the United Nations importantly marked the first anniversary of UN Women, the United Nations Entity for Gender Equality and the **Empowerment of Women** which was the new UN organisation set up in 2010, replacing Unifem, dedicated to gender equality and the empowerment of women. To mark this important anniversary, UN Women Executive Director and former President of Chile, Michelle Bachelet, gave a press conference in New York calling for galvanizing greater commitment and action for women and gender equality, as political and economic upheaval threaten progress on women's rights. With austerity measures, budget cuts and political changes impacting women's lives worldwide, Ms Bachelet outlined the action agenda of the organisation in her first press conference of 2012. She stated that her top priority for 2012 would be to make a renewed push for women's economic empowerment and political participation.

PARTNERSHIP WITH THE ARAB WORLD AND JORDAN

At a meeting in London with Mr Irfan Siddiq, Head of the Arab Partnership at the United Kingdom Foreign and Commonwealth Office in October, Mrs Haifa Al Kaylani, as Founder Chairman of the Arab International Women's Forum, had the pleasure of being informed about the FCO Arab Partnership Fund for the region, and expressed the AIWF interest and support for this timely initiative.

The Foreign & Commonwealth Office Arab Partnership Fund launched in February 2011 is supporting economic and political development across the Middle East and North Africa over four years. The funding for the initiative will help the UK work in partnership with regional governments and international partners to provide technical assistance, help equip the region's youth with professional skills, encourage enterprise and harness the power of UK businesses and corporate social responsibility programmes to contribute to the region's development. The Arab Partnership Initiative developed as a response to the limited opportunities for political, social and economic participation in the Arab world that contribute to long-term instability and undermine security and prosperity builds on longstanding UK work in this area.

The Arab Partnership Fund was among the subjects discussed when Mrs Al Kaylani recently met **HE Peter Millett, British Ambassador to Jordan** at the British Embassy when

on a visit to Amman and had the opportunity to exchange information on the mission of AIWF, the forthcoming Sharjah Conference and the work of the **UK Foreign & Commonwealth Office in Jordan.**

Dina Al-Kilani, Projects Officer, British Embassy, **Amman** has detailed the seven projects currently being funded in Jordan under the Arab Partnership Programme predominantly targeting the country's youth under initiatives relating to youth employability and private sector development. Such initiatives provide capacity building in leadership skills to Jordanian entrepreneurs to support private sector development through the provision of mentors; encourage entrepreneurs to start their own businesses by equipping them, through training with the necessary tools and skills to lead successful businesses and prepare them to receive investments. One project encourages journalists in the region to investigate issues that are important and relevant to the region and its people through the investigative Reporter of the Year Competition and another aims to strengthen Civil Mediation Services in Jordan by supporting the growth and increased uptake of mediation services.

AIWF COOPERATING ON YOUTH INITIATIVES WITH EDUCATION FOR EMPLOYMENT (EFE)

Following Mrs Al Kaylani's meeting with Mr Jamie McAuliffe, President and CEO, Education for Employment Foundation during her visit to Washington DC in October 2011, and in accordance with AIWF's mission of focusing on the employment needs of women and youth of both genders, particularly in the Arab region, AIWF is pleased to showcase the work that the foundation in currently involved with in the region.

Education for Employment (EFE) was founded on the belief that when young women and men have jobs and hope to build a future, they help lay the foundation for peaceful, stable and prosperous societies. EFE has built partnerships with the private sector in Yemen, Jordan, Palestine, Egypt and Morocco and established local non-profit affiliates that are dedicated to youth training, employment and civic engagement. To date, EFE has placed over 2,500 youths in jobs across the Middle East and North Africa. Now, EFE is proud to announce its newest affiliate: EFE-Tunisia. It was established in 2011 as a local nonprofit organization to address the high youth unemployment rate, which was identified as a major priority for the Tunisian government in the post-revolution phase. EFE-Tunisia's Board of Directors is chaired by former Minister of Vocational Training and Employment, M. Said Aidi, and comprises a number of leading figures from the Tunisian private sector.

With a mission to provide youth with opportunities to build a better future for themselves, their families and their communities, EFE-Tunisia is developing programs that will bring together Tunisian and international partners for public-private partnerships dedicated to youth economic opportunity. Over the next three years, EFE-Tunisia will provide training linked to employment for over 1000 young people with an important focus on reaching fifty percent young women. EFE graduates will also be enrolled in an alumni program that links them with mentoring, professional development and continuing education courses, and engages them in civic participation activities. EFE-Tunisia's first training program is scheduled to launch in April 2012. The success of EFE is further illustrated by the article that follows by the CEO of the Jordan Program.

AIWF COOPERATING WITH YOUTH INITIATIVES IN JORDAN

During Mrs Haifa Al Kaylani's visit to Amman, Jordan and a meeting with **Mayyada Abu-Jaber**, **CEO EFE**, **Jordan**, looking at youth employment initiatives in the region, AIWF is delighted to detail the work being carried out in Jordan by EFE.

In 2006, EFE established the Jordan Career Education Foundation (JCEF), a national initiative to develop employer and market-driven training programs to give youth the skills they need to build a career. JCEF partners with local businesses to identify their needs and works with national and international academic partners to design tailored courses so that students will have relevant, employable skills. Since 2006, JCEF has trained over 1,987 youths in 12 program areas and over fifty sessions, placed 70 % of youth directly into jobs, and maintained a sixmonth retention rate of 75.6%. JCEF programs vary based on the targeted economic sector and participants' level of education.

JCEF is viewed as the premier leader in youth employment projects among donor organizations and government ministries. In 2010, JCEF was awarded USAID funded grants to work on the Youth: Work Jordan project targeting marginalized youth in Amman and Irbid. This program would fall under the Development Model mandate. The program focuses on the employment, empowerment, and encouragement of youth to become actively productive citizens within their local communities. As part of this project, JCEF has trained almost 1,500 youths and placed almost 50% of them in jobs. In order to manage this growth, JCEF has trained local CBOs to conduct training sessions and to forge partnerships within their local communities. JCEF was the quality control arm for these CBOs, delivering quality curricula and a comprehensive M&E system to evaluate and follow up on programming.

This year, JCEF received funding from mid-contracting company in Jordan to train 400 youths on the "G4-welding technology". The youths will be placed in the newly constructed phosphorus factory in the south of Jordan (Ma'an).

JCEF's main focus is towards building effective collaborative partnerships with the private sector to respond to: business needs, demand for a skilled workforce and the preparation of potential employees for job placement in the fastest growing career fields. JCEF has formulated an active Board of Directors and a Business Advisory Council consisting of business representatives from all sectors. JCEF has fostered relationships with international and local institutions as well as foundations. Furthermore, JCEF has formed strategic partnerships with organizations such as Microsoft, McGraw Hill Publishers, Manpower International, Talal Abu-Ghazaleh Group, Jordan River Foundation and Ruwwad.

JCEF targets youth that lack opportunities and come from remote, underprivileged areas; 70% of the youth that participated in JCEF's projects come from the 42 pockets of poverty in Jordan. JCEF offers free training and employment programs and expects its alumni to pay it forward through volunteerism and community participation. Although, private sector are expected to contribute to the training, there remain funding gaps which if closed, JCEF will be able to train and employ thousands of youths annually.

JCEF believes engaging and empowering youths by providing them with job training and placement opportunities will directly aid in the alleviation of the increasing poverty levels in Jordan.

AIWF SUPPORTS THE FORUM OF BUSINESSWOMEN OF THE MEDITERRANEAN TURIN, SALONE DEI CONGRESSI, 18-19 NOVEMBER 2011

It was with great pleasure that I attended, representing Mrs Haifa Al Kaylani, Chairman AIWF, the Businesswomen of the Mediterranean Forum which was held in Turin on 18-19 November 2011. The meeting was organised by Confcommercio of the Piedmont region and the Chamber of Commerce of Turin in cooperation with No Peace without Justice (NPW), the NGO founded by Senator Emma Bonino.

The participants from different countries of the Middle East including Algeria, Egypt, Jordan, Lebanon, Libya, Morocco, Tunisia and Turkey arrived on November 17th; we were very well received by the Ascom Confcommercio Torino representative.

The first session on 18 November was a presentation of the event by state officials among them Ms. Maria Luisa Coppa, President of Ascom Confcommercio Torino, Mr. Barberis, President of Turin Chamber of Commerce and Mr. Fassino, the Mayor of Turin. Their speeches were valuable and pointed out important information which would be of interest to the businesswomen participating in this Forum. The role of women entrepreneurs was highlighted as being privileged players, who are able to build and develop trade networks at different production and distribution levels. Mediterranean countries, which are not merely geographically close to each other, share historical and cultural backgrounds facilitating networking among women. The political uncertainty in the current climate in some countries (Egypt, Tunisia and Libya) following the uprisings against the old regimes may be a current obstacle to development, however promises hope of opening up new channels for democracy and offers new opportunities for local businesses and women entrepreneurs.

There are 238,000 companies in Turin, among them leaders in industries such as automotive, aerospace, design, ICT etc. Furthermore, there are 120,000 female entrepreneurs in Turin; most of them work in the sectors of services and commerce. Turin offers a very good quality of life to its inhabitants and is known for its outstanding art, culture and gastronomy while flourishing as an international tourist destination.

During the second session, we had the opportunity to meet with each other and exchange experiences and business opportunities. In my field (tourism), it was a chance to have a closer look at the Mediterranean markets. I met travel agents who were interested in sending Italian groups to Jordan and to receive Jordanian groups. I also met with suppliers for hotel equipment which may help us to improve our services to the highest standards of quality. This came hand in hand with sharing our services with the other participants and promoting the benefits of our hotel. This type of networking is invaluable and enhances businesses by laying the groundwork for future relations with the participating countries.

Furthermore, we attended a discussion which was organised by No Peace without Justice and the topic was "Freedom and Development - Women's Contribution". The keynote speaker and moderator was Senator Emma Bonino and the speakers were from Egypt, Tunisia, Libya, Turkey and Italy. The discussion was on the current conditions of women in the Arab World especially with the Arab Spring,

focused on the civil, political and economic rights of women in these countries. Arab women have historically proven their leadership and efficiency at work during hard times, despite the social restrictions and the various traditions. They have often seized opportunities they faced and will continue to play a key role in the development of their countries.

The farewell dinner provided us with an opportunity to share with the Libyans, Egyptians and Tunisians their happiness for their new found freedom from their past dictatorship and their hope to have a real democratic regime in the near future.



RAISING AWARENESS OF MENA WOMEN LEADERS IN THE MIDST OF THE ARAB SPRING

As the MENA region searches for solutions to integrate women and youth into the local economies, and give women a greater say in how to create more inclusive political and economic cultures, AIWF Corporate Members ,Sarah Wachter and Melanie Cheary Gallagher travelled to Dubai in January to explore those concepts through their learning and development consultancy. The WG concept (wachtergallagher.com), dedicated to building the capacity of leading MENA women in business and government to communicate effectively, was well received in meetings with a wide range of communications experts and consultants with multinational firms, consultancies, and by other local business leaders.

WG was also invited to participate in a three-day conference staged by the British Council and the Reuters Foundation in Istanbul in early March to help Arab women raise awareness of gender issues in the MENA region by creating highly effective media campaigns. A main theme of the conference was, Why are Arab women, who were overwhelmingly involved in the Arab uprisings, mostly absent from the post-revolution governments and councils? Cheary Gallagher chaired a conference segment, and conducted workshops on dealing with journalists, developing strong messages, and using new media. The women who attended the conference from Egypt, Libya, Tunisia, Iraq, Iran, Saudi Arabia, Lebanon, Kuwait and Syria, said after attending the workshop that they felt better-equipped to promote their campaigns in the local, national, and international press.
